This is the last Will and Testament of me

Anthony Burgum of the parish of Aston in the County of
of Shropshire Gentleman first I will and direct that all my just debts
testamentary and funeral expences shall be fully paid and satisfied by
my Executors hereinafter named and appointed out of my residuary estate
I do give devise and bequeath unto my eldest son Anthony George
Burgum his heirs and assigns all that my Cottage or Tenement situate
in the Lands and Hereditaments hereunto belonging called the
fully situate and being in the parish of Linton in the County of Shropshire
with the Appurtenances to hold the same unto and to the use of Anne
Anthony George Burgum his heirs and assigns for ever I also give

and bequeath to my said son Anthony George Burgum the sum of
five hundred pounds I give and bequeath to my daughter Elizabeth
Bennett out of the sum she having already received from me the fortune
intended for her I also give and bequeath to my two sons Thomas
Burgum and Joseph Burgum out of the sum she having been
already provided for and advanced in life by me I give and bequeath to
my daughter Mary Barthelemy the sum of one hundred pounds and to my
daughter Frances Perrine the sum of one hundred pounds they also
having been already partly provided for by me I also give and
bequeath to my son James Burgum the sum of seven hundred pounds
and to my son William Burgum the like sum of seven hundred
pounds and to my daughter Charlotte Burgum the sum of five hundred
pounds I also give devise and bequeath unto my son Robert
Burgum his Executors administrators and assigns all that my house
estate called the Park situate in the parish of Aston in the County of
aforesaid with the Appurtenances to hold the same unto the said
Robert Burgum his Executors administrators and assigns for all my
Estate term and interest therein I also give and bequeath to my said
son Robert Burgum the sum of one hundred pounds in money in
addition thereto I give and bequeath unto my daughter Sarah Burgum
the sum of five hundred pounds and I also give her my best bed and
bedstead in white cloth with the hangings sheets blankets and
furniture belonging to the same and as to all my stock and crops and
all the rest residue and remainder of my Estate and Effects both real and
personal and of what nature sort or kind soever and whatsoever
situated including book and other debts and particularly a debt due and
owing to me from my son in law William Barthelemy mortgage securities
and mortgage Estates now vested in me (if any) I give devise and bequeath
and dispose of the same unto my son Henry Burgum his heirs Executors
administrators and assigns subject to the payment of my just debts funeral
and testamentary expences and the legacies hereinafter by me given
and bequeathed to hold the same unto and to the use of my said son
Henry Burgum his heirs Executors administrators and assigns according to
the nature and quality of such real and personal estate respectively And lastly
I do hereby nominate substitute and appoint my said son Henry Burgum
and my friends Thomas DeLuce of Aston in the County of Shropshire and Philip
Palmer of the parish of Alcester in the County of Gloucester joint Executors
of this my will hereby revoking all former wills by me made and do declare
this only to be my last will and Testament In witness whereof at the said
Anthony Burgum the testator have hereunto set my hand and seal
this seventh day of July one thousand eight hundred and twenty five
Anthony Burgum I signed sealed published and declared by the said
Anthony Burgum as and for his last will and Testament in the presence of
us who have in his presence at his request and in the presence of each of
other subscribed our names as witnesses thereto the interlineation of one of
line having been first made J. J. Collins - J. P. Lucas - J. DeLuce - W. Palmer

Proved at London 4th April 1827 before the Judge by the oath of
Henry Burgum the son one of the Executors to whom Admⁿ was granted
being first sworn by Com^{rs} duly to Admⁿ power reserved to Thomas
DeLuce & Philip Palmer the other Executors
